## Policy Training - Devil's Bridge 26th April

The Welsh Policy Group (WPG) and <u>Vincent Wildlife Trust (VWT)</u> are hosting a joint in-person policy training on 26 April in Devil's Bridge. In the morning we will cover the basics of Welsh environmental policy, followed by the policies that cover species conservation and translocations, and the importance of stakeholder engagement. In the afternoon, experts from the VWT will lead an outdoor pine marten tracking and spoor identification exercise.

#### **BES-NRW Policy Fellowship**

Applications for the BES Policy Fellowship which will be hosted by NRW have reopened.

The BES-NRW Policy Fellowship offers an ecologist the chance to complete a placement embedded within the statutory adviser to the Welsh Government on the natural environment, applying their scientific expertise to a practical policy challenge. The Fellowship will provide a prestigious opportunity for BES members to gain first-hand experience, improving their policy knowledge and awareness, developing their science communication skills, and building their professional networks at an exciting and crucial time for environmental policy.

We have made a few changes for this round of applications. The topic that the Fellow will work on is not pre-defined, applicants should state an area of environmental policy they would be particularly interested in, and they know is relevant in Wales, on their application. Also, applicants do not have to be affiliated with the institution when they submit their application.

## Caffi Ecology: Net Benefits for Biodiversity

Our inaugural Caffi Ecology event on 2 March was a great success!

Caffi Ecology events are opportunities for networking and knowledge exchange that bring together experts from across the research, consultancy, policy and practitioner communities, who may not often have the chance to connect. For the first instalment in this event series, 35 people, including research and consultant ecologists, public agency and government staff, and students, discussed the advantages and potential drawbacks of the approach to Net Benefits for Biodiversity in Wales, and how it compares to the English Biodiversity Net Gain framework.
